#### **INTRODUCTION AS PRESENTED**

In an introduction just before the presentation, Frater Bailey explained that this paper would be "something different", and that the presentation was going to be similar to the song "Proud Mary", as sung by Ike and Tina Turner – in that it would start off "nice", and then "get rough." He said that it would akin to a roller-coaster ride, and that no one would get hurt, as no one would fall off! He also explained that he liked to examine any subject from alternate, or both points-of-view, and that this paper would examine this subject from one point-of-view. He further explained that he has had a history of debating such issues, especially at state-wide public debates in Santa Fe, New Mexico on the question of whether "nuclear power was safe or not" - where each debate team was to be fully prepared, and where the debate teams would be told to be the "pro side" or the "con side" only 2 minutes before the actual debate began. He made it very clear that in order to argue any issue with honesty and integrity; he believed that you needed to know the facts and emotions from both sides of the issue. He then proceeded to read the first four pages of this paper (up to "Part 1 - Introduction"), which as he said was, for this presentation, clearly represented one-point-of-view of the issue of this subject.

#### **LET ME ASK YOU SOME REALLY IMPORTANT QUESTIONS**

How could the President of the United States - George W. Bush Jr. - be quoted by three different sources as saying in November 2005 to an assembled group of Republican Congressional leaders in the Oval Office that: ""Stop throwing the Constitution in my face," Bush screamed back. "It's just a goddamned piece of paper!" [1]

By what right or law can Presidents of the United States issue "Executive Orders" which are "Classified" and are not available to the elected government officials? [2]

How can the top management of the National Security Agency (NSA) finally admit during a recent taped interview on a national TV program and to the rest of its staff, that "Yes – we have been spying on the American Public without their knowledge, and we have kept that fact from our staff." [3]

If we really believe in the handwriting of Abraham Lincoln: "that government of the people, by the people, for the people, shall not perish from the earth." - then WHAT THE HELL HAS HAPPENED? [4]

If we believe that American patriots and loved ones have fought and died - for over 238 YEARS - for a FREE America where there is "No Taxation With Out Representation" and you are still paying "Income Tax" - WHAT THE HELL HAS HAPPENED? [5]

If you wondering why your name is always in all capital letters on your Driver's License, on all contracts, and on all of your banking statements – WHAT THE HELL HAS HAPPENED? [6]

The Federal Reserve Bank has NEVER been audited. WHAT THE HELL HAS HAPPENED??? [7]

#### **HERE IS WHAT IS GOING ON**

You have recently heard that Greece went "Bankrupt", and that many investors in national banks in Greece lost all of their savings. That's not true.

In that banking "crisis", individual account amounts were seized as "BAIL-INS" only if they were over the maximum specified insured amount. This money was seized above that limit without (much) warning because those banks had become insolvent and funds had to come from somewhere.

So... Could the same thing happen here in the United States, if the United States went "Bankrupt?" Yes it could. Will the US go "Bankrupt?" No it won't. Why not?

Because the United States has already gone "Bankrupt" in March 1933 and has created a "NATIONAL EMERGENCY!" We in the United States are still in a state of "National Emergency" and the US government is now and has been for 71 years in a "State of National Emergency." Under that "National Emergency" the US Government is being funded solely by the Federal Reserve Bank, and the US Government is acting under the "WAR AND EMERGENCY POWERS ACT", which can and does supersede the application of the US Constitution and your Constitutional Rights!!! [8]

First, you need to know that, only corporations can have bank accounts. For many years in the USA, the issuance of a "Birth Certificate" creates a corporation in your name in ALL CAPITAL LETTERS where money is deposited for your use throughout your life. This is called a "straw-man" corporation. When you begin working, a unique "Tax Identification Number (TIN)" is created and linked to that corporation. Unless you take "control" of this straw-man corporation (when you become of age), then when you go to a bank for a loan, they will take the funds out of that straw-man account, give you the loan, and charge you interest. There is a way to take control of your straw-man corporation, by filing a Federal UCC-1 Form (Uniform Commercial Code) at a major Federal Reserve Bank (like in Seattle), and I know several people that have done so. All you need is to take with you: the Courage to do so, the Straw Man corporation papers, and your TIN man, and follow the "yellow brick road" to the Wizard of OUNCES at the bank. A prominent and well-versed lawyer named L. Frank Baum saw this "new way of banking" coming in the early 1930s and he wrote a book (or the original screen play) which eventually became "The Wizard Of Oz -- Movie Script." [9]. However, the real Truth about the details of the script can be found in posts by legal and banking research groups [10]. As the details emerge, other historical sources are also needed to understand the complete set-up [11]. But I digress... on purpose...

The US President has the "Power" in this time of "National Emergency" to use the "Powers" granted unto him under the "War and Emergency Powers Act" to basically perform whatever action he or she sees fit to perform in the name of "The National Emergency" - WITHOUT Congressional Approval or oversight. If you look carefully, you can see that this has happened several times in your lifetime.

A summary of the "War and Emergency Powers Act" is given below, as researched by the United States Constitutional Research Center.

I won't go into the details during this presentation. The full report is only 32 pages long, and is available on internet websites in the references below

### **THE MAJOR POINTS TO REMEMBER ABOUT ALL THIS ARE**

The Federal Reserve Bank (the FED) took control of the USA Corporation when it went "Bankrupt" in March 1933. This means that the people of the USA then and now use the bank notes of the FED and they are responsible for any debts of using these notes. The Federal Reserve Bank is a PRIVATE BANK,

owned by several private banks mostly located in Europe. It is not associated in any way with the offices of the US Government, except the US Treasury Department - which is tasked to print the bank notes. The US "Citizens" then owe the FED "interest" on every single bank note it prints and that they receive. Payment of that "interest" was accomplished by the creation of the Internal Revenue Service (the IRS). You will note that without the source of any other debt-free currency, anyone operating in this system can mathematically NEVER get out of debt!

All other forms of financial analyses, international borrowing, import figures, export figures, trade deficit numbers, gross national product charts, and the sale of treasury bonds, ALL are subservient to this one fact: when you use such debt currency, you will never balance the "budget", and you will never "get out of debt." Period.

### **THIS IS WHAT WE HAVE NOW**

"Almost all the problems we are facing today can be traced back to a single point of origin, in a time of national trouble and despair. It was at this point, when our nation struggled for its survival, that the Constitution of the United States of America was effectively cancelled. We are in a State of Emergency!"

"In 1973, in Senate Report 93-549 (Exhibit 10), the first sentence reads,"

"Since March the 9th, 1933, the United States has been in a state of declared national emergency."

Therefore:

The US President under this "National Emergency:" HAS the Legal Right to issue "Classified Executive Orders."

Classified Executive Orders mean that the people of America do not know - and ALMOST ALL of the elected government officials of the United States of America do not know - what the President is doing or signing in their name.

**This is NOT "government of the people, by the people, for the people."**

Instead it seems to be: Government of the banks, by the banks, and for the banks.

The IRS was formed to collect "interest" on the use of these bank notes, by imposing an "income tax". The law to create "income tax" in the United States was never ratified; it fell short of votes. Although the law is illegal, it is intensely and viciously enforced. We therefore have once again the sole reason for the Revolutionary War:

**This is "Taxation Without Representation."**

Not taxation by a foreign country – but taxation by a foreign BANK!

Patrick Henry once proclaimed: "Give Me Liberty Or Give Me Death." [12]

"Is life so dear, or peace so sweet, as to be purchased at the price of chains and slavery? Forbid it, Almighty God! I know not what course others may take; but as for me, give me liberty or give me death!"

What is so different now - than as to what it was like then?

### **SO WHAT ARE YOU GOING TO DO?**

In 1933 (Exhibit 9), Congressman Beck, speaking from the Congressional Record, states,

"I think of all the damnable heresies that have ever been suggested in connection with the Constitution, the doctrine of emergency is the worst. It means that when Congress declares an emergency, there is no Constitution. This means its death. It is the very doctrine that the German chancellor is invoking today in the dying hours of the parliamentary body of the German republic, namely, that because of an emergency, it should grant to the German chancellor absolute power to pass any law, even though the law contradicts the Constitution of the German republic. Chancellor Hitler is at least frank about it. We pay the Constitution lip-service, but the result is the same."

Congressman Beck is saying that, of all the damnable heresies that ever existed, this doctrine of emergency has got to be the worst, because once Congress declares an emergency, there is no Constitution. He goes on to say,

"But the Constitution of the United States, as a restraining influence in keeping the federal government within the carefully

prescribed channels of power, is moribund, if not dead. We are witnessing its death-agonies, for when this bill becomes a law, if unhappily it becomes a law, there is no longer any workable Constitution to keep the Congress within the limits of its Constitutional powers."

What bill is Congressman Beck talking about? In 1933, "the House passed the Farm Bill by a vote of more than three to one." Again, we see the doctrine of emergency. Once an emergency is declared, there is no Constitution.

The cause and effect of the doctrine of emergency is the subject of this Report.

In 1973, in Senate Report 93-549 (Exhibit 10), the first sentence reads,

"Since March the 9th, 1933, the United States has been in a state of declared national emergency."

In the introduction to Senate Report 93-549 (Exhibit 11):

"A majority of the people of the United States have lived all their lives under emergency rule."

Remember, this report was produced in 1973. The introduction goes on to say:

"For 40 years, freedoms and governmental procedures guaranteed by the Constitution have, in varying degrees, been abridged by laws brought into force by states of national emergency."

The introduction continues:

"And, in the United States, actions taken by the government in times of great crisis have -- from, at least, the Civil War -- in important ways shaped the present phenomenon of a permanent state of national emergency."

How many people were taught that in school? How could it possibly be that something which could suspend our Constitution would not be taught in school?

Amazing, isn't it?
